PROJECT DESCRIPTION: A Administrative Use Permit application for Owner-Operator Truck Parking. The proposed project will consist of parking for 2 trucks and 4 trailers. The parcel has direct access to South Manthey Road. The parcel is served by on-site well, septic, and natural storm drainage. The parcel is not under Williamson Act contract.

The Property is zoned AG-40 (General Agriculture, 40-acre minimum) and the General Plan designation is A/G (General Agriculture).
